### Delisting Centralschweizerische Kraftwerke AG, Lucerne

On 25 September 2014, Centralschweizerische Kraftwerke AG, Lucerne (Swiss Security Number 2'060'347 / ISIN CH0020603475) applied for the delisting of all of its listed registered shares with a par value of CHF 0.50 each. SIX Exchange Regulation granted this application on 8 October 2014. The delisting takes place on 2 February 2015, the last trading day on SIX Swiss Exchange will be on 30 January 2015.
