SIX Exchange Regulation AG publishes the substantiated decision regarding delisting of LumX Group Limited, St. Peter Port, Guernsey, UK

LumX Group Limited has requested that all of its listed registered shares (Swiss Security Number 3'381'261 / ISIN GG00B247Y973) with a nominal value of CHF 0.10 each shall be delisted from SIX Swiss Exchange. SIX Exchange Regulation AG has approved the companies' application on 30 January 2020.
