Form of securities: The shares may be in bearer or registered form at the discretion of subscribers. Pursuant to Article L. 214-4 of the Monetary and Financial Code and Decree 83-359 of 2 May 1983 governing the system of securities, the securities must be registered in accounts kept by the issuer or an authorised intermediary, as applicable. The rights of the holders will be represented by a registration in an account in their name (i) at the intermediary of their choice for bearer shares or (ii) with the issuer and, if they wish, with the intermediary of their choice for registered shares. As of the date of the Listing Prospectus only shares in bearer form have been issued. No individual certificates for shares will be issued by the Company.

Clearing and Settlement: The shares traded on SIX Swiss Exchange are settled via SIX SIS.

The Listing Prospectus is the only authoritative source of information on the listing.

This listing notice does not constitute an issuing prospectus within the meaning of Art. 652a of the Code of Obligations.
