**COMMUNIQUÉ NO. 5/2015  
OF 23 JUNE 2015**

***CONNEXOR Events now compulsory for the fulfilment of regular reporting obligations for derivatives, amendment to the Directive on Regular Reporting Obligations for Issuers of Equity Securities, Bonds, Conversion Rights, Derivatives and Collective Investment Schemes (DRRO)***

**I. BACKGROUND**

In its Communiqué 2/2015 of 23 February 2015, SIX Exchange Regulation announced that, as of **1 July 2015**, it will be compulsory to use CONNEXOR Events to fulfil the reporting obligations for derivatives issuers that are listed below. As of this date, issuers will no longer be permitted to fulfil these obligations by submitting an Official Notice.

- Increase or reduction in number of securities
- Achievement of threshold values that affect the price or valuation of the derivative (e.g. in the case of barrier options)
- Early termination by the issuer

**II. AMENDMENT TO ANNEX 3 DRRO**

To reflect this change, points 2.02, 2.03 and 2.07 of Annex 3 DRRO will be amended as follows:
